## Terms of Reference

Subscription costs will be made known to members at the time of joining and at membership renewal.

- Membership is open to those aged 18 and over. Under 18-year-old, living at home may be included in Family Membership.
- The Jet Age Museum is compliant with the General Data Protection Regulations (GDPR) and will only use your information for Museum communications.

### Types of Membership:

- Single: One Person
  - Joint: One Person plus one additional adult added to their record. Additional adult must be resident at the same address as the member.
  - Family: One Person plus one additional adult and their children added to the record. All additional persons must be resident at the same address as the member.
  - Life: One Person for the duration of their life.
  - The annual expiry date for membership will be the last day of the month of joining.
  - Membership renewal reminders will be sent to the member one month prior to expiry date on receipt of data consent
  - Irrespective of how payment is made, the Membership Renewal Form must be completed every year to ensure all details held by the Museum are accurate.

### Summary of Terms and Conditions in GAC Articles of Association

- Becoming a member implies acceptance of the T&Cs included in the GAC Articles of Association.
  - To be eligible to vote at meetings you must be a member of GAC. For Joint or Family Memberships only the named member is eligible to vote at meetings.
  - You will become a member of the Company No. 2141333, which is limited by guarantee. In the event of the company being wound up, your liability is limited to £1.00.
  - Members will be expected to respect the aims and objectives of GAC/JAM and help with their achievements when able.
  - Acceptance as a member will commence on receipt, by the Jet Age Museum Membership Secretary, of a completed Application and full payment of the annual joining fee.
  - Member must pay their annual subscription within 4 weeks of their membership expiry date or their status will be changed to Ex-Member.
  - If the subscription is not paid within 6 months of the renewal date, the member and any additional joint or family records will be classed as lapsed and deleted from the museum's membership database. From this point forward, they will no longer be classed as a member and not entitled to any membership benefits.
  - Any Member may resign their membership in writing to the Membership Secretary.
  - A Full copy of the Articles of Association is available to view at the Museum

## Privacy Notice

This notice is to inform Gloucestershire Aviation Collection (GAC) Members of the nature of the personal data we hold, how it is used, where that data is held, how you can view that data and lastly, what happens when membership of GAC ceases.

### Data Collection, Retention and Use

When you join or renew membership of GAC you will be asked to provide your name, address, telephone number and Email address. This information is necessary to enable GAC to carry out its legitimate 'membership' activities; by signing the GAC membership form you will be consenting to the processing of the data provided as detailed below. The information you provide will be entered onto the Membership Database managed by the Membership Secretary. Access to the Membership Database is restricted to the Membership Secretary, Deputy and the IT Administrator. The hard copy forms completed by you will be retained in a lockable filing cabinet in the Jet Age Museum office, accessible only to those same people.

Your personal data will be used only for the purposes of contacting you regarding GAC membership administration; for example, membership renewal reminders and notices of general meetings. If you wish to receive membership benefits, namely the quarterly News Letter, Club Night information, and in addition be kept informed of other GAC & Jet Age activities, including significant achievements, events and fund raising pursuits (in which you may be invited to contribute) you will need to Opt-in to this service on the membership application or renewal form. If you do not Opt-in, then we will not be able to communicate with you on anything other than basic GAC membership administrative matters.

Personal data you have provided is not shared with any other organisation or agency but may be correlated internally with information on the Volunteer databases should you also be a Jet Age volunteer.

### Viewing personal data held by Jet Age

Your personal data is available for you to view by contacting the Museum Manager via the normal Jet Age Museum contact channels. As an all-volunteer organisation open to the public at weekends, Bank Holidays and school holiday Wednesdays only, actual viewing times will, by necessity, be by negotiation.

### Cessation of Membership

If you inform the Membership Secretary that you no longer wish to be GAC Member all your personal details will be deleted or destroyed immediately. However, if you do not renew your membership when requested, all your personal details will be held for 6 months after your membership renewal date.

### Your rights

GAC Members have the right to view the personal data held on them and request information to be deleted should it be so desired. However, if the basic information of name, telephone number and/or Email address is not retained for contact purposes then it may not be possible to provide that GAC Member with the information necessary for membership to be continued.
